Rule 314 - Fees for Architectural Coatings Product Upload File Specification

The upload text file consists of variable length, tab delimited ASCII character records with a carriage return and line feed after each product. There is no header record allowed.

Each product comprises one record. A tab delimiter is required between each field even if the field is optional and data is not included. This means that any tabs and CR/LF's in the text field must be stripped out before uploading. Apostrophes, commas, quotation marks and trademark symbols (TM ® ©) must also be stripped out before uploading.
