Re: Support the Ports' Cooperative Proposal Over Proposed Rule 2304

Dear Chair Delgado:

On behalf of Rexford Industrial, I respectfully urge you to support the cooperative agreement proposal presented by the Ports of Los Angeles and Long Beach in lieu of adopting Proposed Rule 2304 (the "Ports ISR").

Rexford Industrial is a public REIT (NYSE: REXR) headquartered in Los Angeles that operates 422 properties totaling over 51M square feet exclusively located in Southern California. The 1613 diverse tenants that occupy our portfolio employ over 30,000 local workers, and Rexford's commitment to the betterment of the communities and businesses we serve is reflected in our industry leading sustainable development and operational practices designed to reduce emissions, embodied carbon, and the reliance on fossil fuels. Our tenants are committed to environmental stewardship and comply with South Coast AQMD Rule 2305 (the "Warehouse ISR") and the WAIRE Program.

As stakeholders closely connected to the operations of the regional ports, we recognize and value their unparalleled economic importance — supporting hundreds of thousands of jobs and empowering national supply chains. Ensuring that the environment is improved while also considering impacts to commerce is especially crucial for the Southern California region as other national ports are expanding and businesses are leaving the State.

The Ports' proposed cooperative framework offers a practical and accountable solution that strengthens the Clean Air Action Plan, accelerates environmental progress, and avoids the unintended consequences that a rigid regulatory mandate may cause.

We respectfully request that you pause the rulemaking process and direct SCAQMD staff to negotiate a cooperative agreement with both Ports, and the Cities of Los Angeles and Long Beach.
