## **RE:** Proposed Amended Regulation III – Fees

NOTICE IS HEREBY GIVEN that a public hearing on the matter of adoption of rules and regulations for the South Coast Air Quality Management District (South Coast AQMD), or the amendments thereto, will be held on Friday, May 2, 2025 in the Dr. William A. Burke Auditorium at South Coast AQMD, 21865 Copley Drive, Diamond Bar, CA 91765, at 9:00 a.m., at which time evidence will be taken and all interested persons will be heard by the South Coast AQMD Governing Board. The meeting will be conducted through a hybrid format of in-person and/or virtual attendance via videoconferencing and by telephone with opportunities for public comment. NOTICE IS FURTHER GIVEN that the South Coast AQMD is considering the adoption of Proposed Amended Regulation III which includes: 1) an increase in most fees by 3.0% consistent with the Consumer Price Index (CPI) and Rule 320; 2) new or modified fees to provide cost recovery for regulatory actions taken by the South Coast AQMD that include, but are not limited to, Rule 1180 and 1180.1 operation and maintenance fees on refinery related community air monitoring, new fees for optional Rule 212(c) public notice distribution, and new post-reporting deadline fees related to implementation of Rule 2305 (WAIRE Program), and 3) administrative changes in Regulation III that include clarification, deletions, insertions, or corrections of existing rule language, which have no fee impact. The proposals which have no fee impacts include but will not be limited to, clarifications on facilities that are not eligible for abbreviated reporting, clarifications that facilities subject to Rule 317.1 are subject to filing annual emissions reports and extending the annual emission report filling deadline for 2025 emissions to May 1, 2026.

**NOTICE IS FURTHER GIVEN** that Proposed Amended Regulation III will not be submitted for inclusion into the State Implementation Plan.

**NOTICE IS FURTHER GIVEN** that Proposed Amended Regulation III does not impose a new emission limit or standard, make an existing emission limit or standard more stringent, or impose new or more stringent monitoring, reporting, or recordkeeping requirements and therefore, a comparative analysis pursuant to Health and Safety Code Section 40727.2 is not required.

NOTICE IS FURTHER GIVEN that pursuant to the California Environmental Quality Act (CEQA) Guidelines Sections 15002(k) and 15061, the proposed amendments to Regulation III which involve charges by public agencies for the purpose of meeting operating expenses and financial reserve needs and requirements are statutorily exempt from CEQA pursuant to CEQA Guidelines Section 15273. In addition, the proposed amendments to Regulation III which have no fee impact and are strictly administrative in nature are exempt from CEQA pursuant to CEQA Guidelines Section 15061(b)(3). A Notice of Exemption will be prepared pursuant to CEQA Guidelines Section 15062, and if the proposed project is approved, the Notice of Exemption will be filed for posting with the State Clearinghouse of the Governor's Office of Planning and Research, and with the county clerks of Los Angeles, Orange, Riverside and San Bernardino counties.
