

## NOTICE OF PUBLIC HEARING

PROPOSED ADOPTION OF, OR AMENDMENT TO, THE RULES AND REGULATIONS  
OF THE SOUTH COAST AIR QUALITY MANAGEMENT DISTRICT  
AND PROPOSED SUBMISSION INTO THE STATE IMPLEMENTATION PLAN

### **RE: Proposed Amended Rule 1124 –Aerospace Assembly and Component Manufacturing Operations**

**NOTICE IS HEREBY GIVEN** that a public hearing on the matter of adoption of rules and regulations for the South Coast Air Quality Management District (South Coast AQMD), or the amendments thereto, will be held on Friday, **March 6, 2026**, in the Dr. William A. Burke Auditorium at South Coast AQMD, 21865 Copley Drive, Diamond Bar, CA 91765, at **9:00 a.m.**, at which time evidence will be taken and all interested persons will be heard by the South Coast AQMD Governing Board. The meeting will be conducted through a hybrid format of in-person and/or virtual attendance via videoconferencing and by telephone with opportunities for public comment. **NOTICE IS FURTHER GIVEN** that the South Coast AQMD is considering the adoption of Proposed Amended Rule 1124 – Aerospace Assembly and Component Manufacturing Operations (PAR 1124). The objective of PAR 1124 is to reduce the health risk from the use of two solvents, para-chlorobenzotrifluoride (pCBtF) and *tert*-butyl acetate (t-BAc), that were determined to have carcinogenic health effects, by the California Office of Environmental Health Hazard Assessment. PAR 1124 includes a future prohibition for aerospace materials that are not reliant on pCBtF and t-BAc and alternative reactivity-based VOC limits for several coating categories required to transition away from pCBtF. For aerospace materials that do rely on pCBtF or t-BAc to comply with the VOC limits, PAR 1124 provides three compliance options for facilities: 1) install air pollution control equipment; 2) apply for a low-use permit limit; or 3) phase out the use of pCBtF and t-BAc and transition to alternatives. In addition, PAR 1124 also include clarifications and updates to definitions, rule structure, test methods, and references for consistency with other South Coast AQMD rules.

**NOTICE IS FURTHER GIVEN** that PAR 1124 will be submitted to the California Air Resources Board and United States Environmental Protection Agency for inclusion into the State Implementation Plan.

**NOTICE IS FURTHER GIVEN** that PAR 1124 implements Sections 110, 172, and 182(e) of the federal Clean Air Act.

**NOTICE IS FURTHER GIVEN** that a written analysis pursuant to Health and Safety Code Section 40727.2 has been prepared that identifies all existing federal air pollution control requirements, all South Coast AQMD existing and proposed rules and regulations, and all pollution control requirements and guidelines that apply to the same equipment or source type as the rule proposed for amendment.

**NOTICE IS FURTHER GIVEN** that pursuant to California Environmental Quality Act (CEQA) Guidelines Sections 15002(k) and 15061, PAR 1124 is exempt from CEQA pursuant to CEQA Guidelines Sections 15061(b)(3). A Notice of Exemption will be prepared pursuant to CEQA Guidelines Section 15062, and if the proposed project is approved, the Notice of Exemption will be filed for posting with the county clerks of Los Angeles, Orange, Riverside and San

Bernardino counties, and the State Clearinghouse of the Governor's Office of Land Use and Climate Innovation.

**NOTICE IS FURTHER GIVEN** that the South Coast AQMD staff will prepare and make available the following documents on or before February 3, 2026, for consideration by the South Coast AQMD Governing Board, including:

- Draft PAR 1124
- Draft Staff Report for PAR 1124, which includes the Comparative Analysis
- Draft Socioeconomic Impact Assessment, included in the Draft Staff Report
