

NOTICE OF PUBLIC HEARING

PROPOSED ADOPTION OF, OR AMENDMENT TO, THE RULES AND REGULATIONS OF THE SOUTH COAST AIR QUALITY MANAGEMENT DISTRICT AND PROPOSED SUBMISSION INTO THE STATE IMPLEMENTATION PLAN

RE: Proposed Amended Rule 1171 – Solvent Cleaning Operations

NOTICE IS HEREBY GIVEN that a public hearing on the matter of adoption of rules and regulations for the South Coast Air Quality Management District (South Coast AQMD), or the amendments thereto, will be held on Friday, **June 6, 2025**, in the Dr. William A. Burke Auditorium at South Coast AQMD, 21865 Copley Drive, Diamond Bar, CA 91765, at 9:00 a.m., at which time evidence will be taken and all interested persons will be heard by the South Coast AQMD Governing Board. The meeting will be conducted through a hybrid format of in-person and/or virtual attendance via videoconferencing and by telephone with opportunities for public comment. NOTICE IS FURTHER GIVEN that the South Coast AQMD is considering the adoption of Proposed Amended Rule 1171 – Solvent Cleaning Operations (PAR 1171). The objective of PAR 1171 is to phase out two compounds used in solvent cleaning materials, para-Chlorobenzotrifluoride (pCBtF) and *tert*-Butyl Acetate (*t*-BAc), that were determined to have carcinogenic health effects in 2020 and 2018 respectively, by the California Office of Environmental Health Hazard Assessment. PAR 1171 includes a future effective prohibition for cleaning solvents formulated with pCBtF and *t*-BAc that allows for products in the supply chain to continue to be sold and used for specified periods of time, and includes alternative compliance options for specific cleaning activities, and revisions for clarity.

NOTICE IS FURTHER GIVEN that PAR 1171 will be submitted to the California Air Resources Board and the United States Environmental Protection Agency for inclusion into the State Implementation Plan.

NOTICE IS FURTHER GIVEN that PAR 1171 implements Sections 110, 172, and 182(e) of the federal Clean Air Act .

NOTICE IS FURTHER GIVEN that a written analysis pursuant to Health and Safety Code Section 40727.2 has been prepared that identifies all existing state and federal air pollution control requirements, all existing and proposed South Coast AQMD rules and regulations, and all air pollution control requirements and guidelines that apply to the same equipment or source type as PAR 1171.

NOTICE IS FURTHER GIVEN that pursuant to California Environmental Quality Act (CEQA) Guidelines Sections 15002(k) and 15061, PAR 1171 is exempt from CEQA pursuant to CEQA Guidelines Sections 15061(b)(3) and 15308. Further, there is no substantial evidence indicating that the exceptions to the categorical exemptions, as set forth in CEQA Guidelines Section 15300.2, apply to the proposed project. A Notice of Exemption will be prepared pursuant to CEQA Guidelines Section 15062, and if the proposed project is approved, the Notice of Exemption will be filed for posting with the county clerks of Los Angeles, Orange, Riverside and San Bernardino counties, and the State Clearinghouse of the Governor's Office of Planning and Research.

NOTICE IS FURTHER GIVEN that at the conclusion of the public hearing, consistent with Health and Safety Code Section 40726, the South Coast AQMD Governing Board may make other modifications to PAR 1171, which are justified by the evidence presented, or may decline to adopt some or all of the proposed amendments.
