

NOTICE OF PUBLIC HEARING

PROPOSED ADOPTION OF, OR AMENDMENT TO, THE RULES AND REGULATIONS OF THE SOUTH COAST AIR QUALITY MANAGEMENT DISTRICT AND PROPOSED SUBMISSION INTO THE STATE IMPLEMENTATION PLAN

RE: Proposed Amended Rule 461 – Gasoline Transfer and Dispensing

NOTICE IS HEREBY GIVEN that a public hearing on the matter of adoption of rules and regulations for the South Coast Air Quality Management District (South Coast AQMD), or the amendments thereto, will be held on Friday, **September 4, 2026** in the Dr. William A. Burke Auditorium at South Coast AQMD, 21865 Copley Drive, Diamond Bar, CA 91765, at **9:00 a.m.**, at which time evidence will be taken and all interested persons will be heard by the South Coast AQMD Governing Board. The meeting will be conducted through a hybrid format of in-person and/or virtual attendance via videoconferencing and by telephone with opportunities for public comment. NOTICE IS FURTHER GIVEN that the South Coast AQMD is considering the adoption of Proposed Amended Rule 461 – Gasoline Transfer and Dispensing (PAR 461). The objective of PAR 461 is to streamline recordkeeping requirements applicable to operators of fleets with only motor vehicles equipped with Onboard Refueling Vapor Recovery (ORVR) systems by including a new option to allow for recordkeeping of total daily fuel dispensed in lieu of fuel dispensed on a per-vehicle basis. PAR 461 will also include editorial corrections and removes an outdated provision which has been superseded by state reporting requirements.

NOTICE IS FURTHER GIVEN that PAR 461 will be submitted to the California Air Resources Board and the United States Environmental Protection Agency for inclusion into the State Implementation Plan.

NOTICE IS FURTHER GIVEN that PAR 461 does not impose a new emission limit or standard, make an existing emission limit or standard more stringent, or impose new or more stringent monitoring, reporting, or recordkeeping requirements and therefore, a comparative analysis pursuant to Health and Safety Code Section 40727.2 is not required.

NOTICE IS FURTHER GIVEN that pursuant to California Environmental Quality Act (CEQA) Guidelines Sections 15002(k) and 15061, since implementing PAR 461 makes administrative clarifications which will not require physical modifications, it can be seen with certainty that the proposed project would not cause a significant adverse impact on the environment. Thus, PAR 461 is exempt from CEQA pursuant to CEQA Guidelines Section 15061(b)(3). A Notice of Exemption will be prepared pursuant to CEQA Guidelines Section 15062, and if the proposed project is approved, the Notice of Exemption will be filed for posting with the county clerks of Los Angeles, Orange, Riverside and San Bernardino counties, and the State Clearinghouse of the Governor's Office of Land Use and Climate Innovation.

NOTICE IS FURTHER GIVEN that the South Coast AQMD staff will prepare and make available the following documents on or before August 4, 2026, for consideration by the South Coast AQMD Governing Board, including:

NOTICE IS FURTHER GIVEN that at the conclusion of the public hearing, consistent with Health and Safety Code Section 40726, the South Coast AQMD Governing Board may make other modifications to PAR 461, which are justified by the evidence presented, or may decline to adopt some or all of the proposed amendments.
