Purpose of This Meeting

The South Coast Air Quality Management District (South Coast AQMD) has scheduled a Public Workshop to present and solicit information and suggestions from the public on Proposed Amended Rule 1144 – Metalworking Fluids and Direct-Contact Lubricants (PAR 1144), which is scheduled for a Public Hearing before the South Coast AQMD Governing Board on April 3, 2026 (subject to change).

Background

Rule 1144 – Metalworking Fluids and Direct-Contact Lubricants (Rule 1144) was adopted in March 2009 to reduce volatile organic compound (VOC) emissions from the use of metalworking fluids and direct-contact lubricants. Two solvents, tert-Butyl Acetate (t-BAC) and para-Chlorobenzotrifluoride (pCBtF), are currently federally exempt from the definition of VOC and could be used in metalworking fluid and lubricant formulations to meet lower VOC emission limits. The California Office of Environmental Health Hazard Assessment (OEHHA) recently identified pCBtF and t-BAC as carcinogens. Control Measure CTS-01 of the 2022 Air Quality Management Plan prioritizes controls to address air toxics, while seeking VOC reductions when technologically feasible.

Objective of Proposed Amended Rule

The primary objective of PAR 1144 is to phase out and prohibit the use of pCBtF and t-BAC as quickly as possible. PAR 1144 proposes a phase-out timeline for metalworking fluid and lubricant manufacturers to cease sale and use of pCBtF- and t-Bac-based products. To support the phase-out, PAR 1144 also includes sell-through and use-through provisions, providing time needed for existing product inventory to be used and suitable replacement products to enter the market.

California Environmental Quality Act

Pursuant to the California Environmental Quality Act (CEQA) and South Coast AQMD's certified regulatory program (Public Resources Code Section 21080.5 and CEQA Guidelines Section 15251(l); codified in South Coast AQMD Rule 110), the South Coast AQMD, as lead agency, is currently reviewing the proposed project (PAR 1144) to determine if it will result in any potential adverse environmental impacts. Appropriate CEQA documentation will be prepared based on the analysis.
