## Nearly \$24 million Awarded to SCAQMD for Zero-Emission Truck Project

In May, SCAQMD learned that it will be awarded \$23.6 million for a statewide zero-emission drayage truck development and demonstration project.

SCAQMD is teaming up with air districts in the Bay Area, Sacramento, San Diego and San Joaquin Valley to make the project a statewide demonstration of 43 zero-emission battery electric and plug-in hybrid drayage trucks serving major California ports. Demonstration trucks and charging infrastructure will be used in all five air districts, providing emission reduction benefits in key areas of California with drayage truck activity.

The funds, from the California Climate Investments program, come from proceeds of the state's cap-and-trade auctions. The goal is to reduce key criteria pollutants, greenhouse gas (GHG) emissions, petroleum usage and toxic pollution where reductions are needed most. They are also designed to accelerate the commercialization of heavy-duty advanced, zero-emission technologies, establishing a path for implementing SCAQMD's clean air plan currently under development.

This is the first large-scale demonstration of zero-emission Class 8 trucks that involves major manufacturers, including BYD, Kenworth, Peterbilt and Volvo. The companies receiving funds have the engineering resources, manufacturing capabilities and distribution networks to support commercialization of advanced technologies related to moving freight to and from the ports. The project will have the cleanest short-haul trucks move cargo from the state's largest ports to distribution centers and rail yards, reducing emissions along some of our state's busiest trade corridors.

Freight transport in California is a major economic engine for the state but also accounts for about half of toxic diesel particulate matter (PM 2.5), 45 percent of the emissions of nitrogen oxides (NOx) that form ozone and fine particulate matter in the atmosphere, and six percent of all GHG emissions in California.

# SCAQMD Announces Executive Reorganization

**O**n June 24th, Wayne Nastri, SCAQMD's Acting Executive Officer, announced a reorganization of the executive staff to improve the agency's operational efficiency as well as its responsiveness to community and regulated interests. "This reorganization will help us improve our use of technology and make us more accountable to the public through increased transparency and efficiency," Nastri said.

Jill Whynot, previously the Assistant Deputy Executive Officer for Planning, Rule Development and Area Sources, has been named to the new position of Chief Operating Officer. In this capacity, she will oversee operational aspects of the agency and allocate available resources to best serve the needs of the agency. She will also assume responsibilities for overall development of succession planning and agency policies. Whynot has been with SCAQMD since 1989 and has served as the Assistant Deputy Executive Officer in Engineering & Compliance and as Director of Strategic Initiatives.

Michael O'Kelly, who previously served as SCAQMD's Chief Financial Officer, has assumed the newly formed position of Chief Administrative Officer. In this role, he will oversee the Finance, Information Management, and Administrative & Human Resources divisions at SCAQMD. Previously, O'Kelly served as Chief of Fiscal Services for the San Bernardino County Employees' Retirement Association.

What was previously the Engineering & Compliance division has been split into two separate divisions, the first is Engineering and Permitting and the second is Compliance and Enforcement. Laki Tisopulos, Ph.D., has been named as the Deputy Executive Officer of the Engineering and Permitting division and will have primary responsibility for the agency's permitting functions. Tisopulos, a licensed professional engineer, holds a doctorate and master's degree in chemical engineering from the University of Southern California. Tisopulos previously served as Assistant Deputy Executive Officer for Science and Technology Advancement and Assistant Deputy Executive Officer for the Planning, Rule Development and Area Sources division. A search will be conducted for a new Deputy Executive Officer to lead the Office of Compliance and Enforcement.

In addition, Derrick Alatorre, previously the Assistant Deputy Executive Officer for Legislative and Public Affairs, has been promoted to Deputy Executive Officer of the Legislative and Public Affairs division. In this capacity, he will be responsible for overseeing the agency's legislative activities locally, statewide and in Washington, D.C. Alatorre will also be responsible for the public outreach and environmental justice activities conducted by SCAQMD, as well as oversee the Media Office, which has become part of the Legislative and Public Affairs division.


The Clean Air Awards honor those who have made outstanding strides toward clean air, while also encouraging and motivating those in their community to get involved, and to make clean air a priority.

## Putting their Mettle on the Pedal: Employees Ride on Bike to Work Day

On Wednesday May 18th, SCAQMD participated in national Bike to Work Week activities by sponsoring an annual Bike to Work event. Twenty-three SCAQMD employees cycled to work for their health and environment. Riding in groups to SCAQMD's Diamond Bar headquarters, the cyclists averaged a travel distance of 14.63 miles; their routes ranged in length from 3.2 miles to an impressive 32.5 miles. Upon arriving at SCAQMD, the cyclists were treated to a welcome reception, including breakfast and participation prizes. Acting Executive Officer Wayne Nastri showed his support for the riders by presenting them with certificates of appreciation.



## UCR Selected as Site for New CARB Southern California Test Lab

After being located for more than 40 years in the City of El Monte, the California Air Resources Board (CARB) vehicle emissions testing laboratory is moving to the University of California-Riverside (UCR). The Arie Jan Haagen-Smit Lab is named after the California Institute of Technology professor who was known as the “father” of air pollution control because in the 1950s he was the first person to document the link between vehicle emissions and Southern California smog. His research led automotive manufacturers to install the first vehicle emissions controls, and he served as CARB’s first chairman in 1968. The air board certifies new vehicles sold in California, and its scientists conduct more than 1,500 tests each year on vehicle emissions at its laboratory. CARB is moving the lab to a larger space so that it can test more vehicles, including heavy-duty trucks using advanced technologies. The tests cover everything from tailpipe emissions to vapors given off during refueling. CARB hopes to break ground at the new site in 2017 and move in by 2020.

## SCAQMD Launches Targeted Outreach Initiative with Google

In late 2015, SCAQMD initiated a targeted outreach pilot program with Google to promote the agency’s clean air efforts. The ads appear on websites based on a variety of factors such as search words, ZIP codes and other demographics. The web ads link the viewer to brief 45-second “pre-roll” videos on YouTube with information about SCAQMD and air quality issues.

Results of the highly successful pilot program led the agency’s Governing Board to expand the program in 2016 as part of its outreach for various SCAQMD programs. The ads will promote a

variety of SCAQMD efforts with the first set of ads highlighting the agency’s “Do One Thing” video and the Residential EV Charging Incentive Pilot Program.

As of late June, the current Google campaign had achieved more than 240 million impressions and more than 2.5 million interactions (either through clicks on ads or videos watched).

## Environmental Justice Community Partnership Holds Workshops in South L.A. and Eastern Coachella Valley

In May, South Los Angeles and Eastern Coachella Valley residents had an opportunity to speak with SCAQMD about the air pollution affecting their communities, as part of two workshops hosted by the SCAQMD's Environmental Justice Community Partnership. The Partnership is a program that aims to strengthen the agency's relationships with environmental justice communities throughout the region.

For the South Los Angeles workshop, SCAQMD partnered with the nonprofit organization Healthy African American Families (HAAF). More than 80 residents participated and expressed their concerns with air pollution's effects on public health, while encouraging SCAQMD to identify further solutions to their problems.

In the Eastern Coachella Valley, SCAQMD partnered with local organizations Comite Civico del Valle, La Union Hace la Fuerza, IVAN, as well as the Coachella Valley Unified School District, which hosted the event at one of its middle schools. Nearly 40 attendees expressed concerns about pesticides, dust, odors, and smoke. They advocated for a cleaner community and for funding and regulations that improve local air quality.

Both workshops featured opportunities for community members to share their stories, and in an atmosphere of partnership, participants divided into smaller groups to discuss concerns most important to them and their communities. They spoke out on a number of key topics such as their concerns over the rise of respiratory problems like asthma, especially among children, and the air quality impacts of specific sources of pollution.

Individuals also wanted to know how they can get more involved, who to call when there is an air pollution problem, and what would be SCAQMD's next steps after each meeting. SCAQMD representatives committed to return to each community with an action plan to help address the issues shared.



## Five Lawn Mower Trade-in Events Scheduled for Fall

The SCAQMD's annual Lawn Mower Exchange events are coming up soon and for Southern Californians looking to replace their gasoline-powered lawn mower with a quieter, non-polluting model, this will be an opportunity not to miss!

This year's program will offer seven lawn mower models from three manufacturers, offering some of the best battery technology yet. Just like the batteries in your cell phone or electric car have gotten better over the years, the advanced technology batteries in these next generation, zero-emission lawn tools are improving each year. Removable and interchangeable batteries, like those that power tool manufacturers use in their professional-grade equipment, are available on some lawn mower models.

One of the mowers even has headlights for mowing on cooler summer nights and many come with a fast charger to quickly recharge the mower's battery. With the trade-in of a working gasoline-powered lawn mower, residents living within the SCAQMD's four-county jurisdiction, can purchase cordless, battery-powered models for between \$100 and \$250. Only 3,000 units are available this year at the five exchange events being held throughout the region.

## New Members Appointed to SCAQMD Hearing Board

In May, the SCAQMD Governing Board appointed new members to the independent SCAQMD Hearing Board.

Dr. Roger L. Lerner was appointed as the new Medical Member with Dr. Monique Castro selected as Alternate Medical Member. Former California State Senator and Los Angeles City Councilman Nate Holden was appointed as a new Public Member while Patricia Byrd was reappointed as a Public Member. The Governing Board also reappointed Robert Copeland and appointed Cynthia Verdugo-Peralta as Alternate Public Members.

A physician specializing in Internal Medicine and Endocrinology, Dr. Lerner has been in private practice in Los Angeles since 1979. He has held academic research positions at USC and UCLA medical schools, continuing the study of human hormonal physiology in health and disease. He has continued to teach over the years at UCLA and at Cedars-Sinai Medical Center, and has authored numerous articles and abstracts pertaining to insulin, glucose and diabetes.

Dr. Castro, who is certified by the American Board of Family Medicine, practiced family medicine for three years at Glendale Adventist Medical Center. She has been an urgent care fellow in the Emergency Room at Pomona Valley Hospital since July 2015.

Holden served over 30 years in the public sector, as a California State Senator, Los Angeles City Councilman, and as Assistant Chief Deputy to Los Angeles County Supervisor Kenneth Hahn. As a City Councilman, he served as Chairman of the Air Quality and Waste Management Committee and Chairman of the Transportation Committee. Now retired from public office, Holden is a consultant specializing in government affairs.

Verdugo-Peralta is a former Governing Board Member who served from April 2000 to March 2007, and has served as a volunteer on many SCAQMD committees and advisory groups.

The Hearing Board is a quasi-judicial panel of five individuals appointed by the Governing Board required by state law to act independently of SCAQMD. They are often the most direct way to appeal a decision regarding the applicability and enforcement of air quality rules and regulations. The Hearing Board hears petitions for variances to air quality rules and regulations, petitions for orders of abatement, and appeals of SCAQMD decisions regarding permits, denials of emission reduction credits, and denials of pollution control plans.

## Studies Show Link Between Particle Exposure and Effects on the Brain

At its April meeting, the SCAQMD Governing Board received a presentation by Dr. Keith Black, Chair of the Department of Neurosurgery and Director of Maxine Dunitz Neurosurgical Institute at Cedars-Sinai Medical Center. Dr. Black presented his work investigating the effects of particulate matter (PM) exposure on brain tumor development.

Dr. Black's studies sought to determine whether exposure to PM resulted in molecular changes in the brain that are associated with development of brain tumors or other brain disorders. After being exposed to PM collected at the intersection of Interstates 91 and 215 in Riverside, the rats used in the experiment showed increased expression of genes in different stages of neurodegeneration and tumor formation. In other words, PM passes through the blood-brain barrier and increases expression of genes associated with inflammatory brain changes, which may be important risk factors for Alzheimer's disease and other neurodegenerative disorders.

As people live longer lives, concerns around Alzheimer's disease and other forms of dementia may increase. The SCAQMD Governing Board Members pointed out that the findings are crucial to communicate the health impacts of air pollution and help combat PM emissions.

## White Paper Identifies Opportunity to Significantly Reduce Emissions From Trucks

A technical white paper co-funded by SCAQMD has identified how large, natural gas trucks can immediately achieve major reductions in air pollution.

Known as the "Game Changer" white paper, the document, published in April explains how near-zero emission heavy-duty natural gas vehicles, fueled by increasing available renewable natural gas, provides a commercially proven, broad-based and affordable strategy to immediately achieve major reductions of criteria pollutants, air toxics and greenhouse gases (GHGs) from America's heavy-duty truck sector.

In 2015, Cummins-Westport certified the world's first heavy-duty engine at near-zero-emission levels. Complementing the NOx reductions provided by this landmark engine is conventional natural gas which provides significant reductions in GHGs. However, RNG completes the game-changing proposition by providing the lowest carbon intensity of any heavy-duty transportation fuel available in the market today. The white paper provides a series of recommendations on opportunities and challenges that would need to be addressed, in two key areas. The first is the availability of heavy-duty near-zero emission natural gas engines and vehicles, and the second is the production and end use of renewable natural gas.

The white paper shows how following a path utilizing both near-zero emission engines and renewable natural gas can achieve unprecedented emission reductions in both criteria and GHG emissions, equivalent if not cleaner than electric vehicles on a well-to-wheels basis. This transition to cleaner fuels is critical to restore healthful air quality to approximately 166 million Americans who reside in areas with exceedingly poor air quality.

# Marian Coleman



**E**arlier this year, Marian Coleman reached her 30th anniversary at SCAQMD. She was recruited just after finishing her degree in Health Sciences with an emphasis in Environmental Health at CSU San Bernardino. “I didn’t seek out the job. SCAQMD sent me applications twice!”

She started as a service station inspector where she learned right away the value of providing good customer service, especially to the “mom & pop” operations that may struggle with understanding SCAQMD rules. ## Board Members Press Case in DC for EPA Petition

**I**n mid-June, a delegation of SCAQMD Governing Board members and staff traveled to Washington, DC, to seek support for its petition urging the federal government to adopt much tougher nationwide emission standards for large trucks to help the region meet federal clean air goals.


The group included Governing Board members John D. Benoit, Judith Mitchell, Dwight Robinson and Dr. Joseph Lyou. They met with senior staff from the White House and the U.S. Environmental Protection Agency, where they discussed the need for an ultra-low NO<sub>x</sub> emission standard for heavy-duty truck engines, up to ten times more stringent than the current standard. NO<sub>x</sub>, or nitrogen oxides is a group of pollutants critical to the formation of smog (or ground level ozone).

The delegation also visited the offices of nearly 40 Senators and Members of the House of Representatives requesting support for the petition. They were joined in some of the meetings by representatives from Northeast States for Coordinated Air Use Management (NESCAUM) and the Advanced Engine Systems Institute (AESI).

Without a nationwide ultra-low NO<sub>x</sub> emission standard, the South Coast will not be able to meet the 2023 deadline for achieving the federally mandated 8-hour ozone standard, which was adopted in 1997 and set at 80 parts per billion. Nor will the region be able to meet the 2031 deadline for the 8-hour ozone standard that was adopted in 2008 and lowered to 75 parts per billion.

The petition was submitted to EPA on June 3, 2016, by SCAQMD along with ten other state and local clean air agencies. Since being submitted, several other states have also joined the petition.
