## A New Direction Sunset of RECLAIM Program



**A**t its January 5, 2018 meeting, the South Coast Air Quality Management District (SCAQMD) Governing Board began the transition of the Regional Clean Air Incentives Market (RECLAIM) market incentive program to a command-and-control regulatory structure requiring Best Available Retrofit Control Technology (BARCT). The shift from this market based air pollution reduction strategy was included in the 2016 Air Quality Management Plan to help reach attainment of federal public health standards for air quality.

Additionally, California State Assembly Bill (AB) 617 which was signed into law requires an expedited schedule for implementing BARCT at greenhouse gas cap and trade facilities that are also subject to RECLAIM. AB 617 requires the implementation of BARCT by these facilities, must occur no later than December 31, 2023.

What is BARCT? BARCT means that a business must utilize the best retrofit air pollution control technology

for existing equipment, taking into account environmental, energy, and economic impacts. In simple terms, BARCT requires that companies install the best air pollution control technology available to reduce air pollution from their facility.

As part of the transition from RECLAIM, staff continues to meet with stakeholders to discuss key issues related to the transition process. In January 2018, SCAQMD Rule 2001 was amended to preclude new non-RECLAIM facilities from entering the nitrogen oxides (NOx) and sulfur oxides (SOx) RECLAIM program. Rule 2002 was also modified to establish the transition process for exiting a facility from RECLAIM, including the use of RECLAIM Trading Credits after a facility exits the program.

A socioeconomic analysis of the

amendments to RECLAIM found that among the 266 facilities currently in the NOx RECLAIM program, none would be affected by the amendment to Rule 2001, while 37 facilities would be initially affected by the amendment to Rule 2002. Of the 37 facilities given initial notifications for exiting the program and based on permitting data, it was determined that these businesses operating RECLAIM equipment are already at BARCT standards and should be ready for exit.

# Check Before You Burn Season Recap

The Check Before You Burn season officially began on November 1, 2017, and ended on February 28, 2018. Despite a record 33 No-Burn days this past winter and late fall, many Southland residents helped keep particulate pollution at bay by not burning wood in their fireplaces during periods of poor air quality.

Persistent inversion layers and a lack of seasonal rainfall greatly diminished natural cleansing of pollutants in the air, which normally occurs as the result of more dynamic weather patterns. As a result, the region experienced more no-burn days this season than in any of the previous

five-years.

However, particulate pollution levels were mitigated by residents' increased participation in the Check Before You Burn program, along with greater awareness of the health effects of wood smoke, indoor or outdoor. Sign-ups for Air Alerts notifications, the SCAQMD's principal tool for alerting the public about No-Burn days, also saw record increases this season, as residents took a more active role in helping to reduce particulate pollution in their communities.

## Community Air Protection Program

The community meetings are focused on providing information on two new state laws, Assembly Bill (AB) 134 and AB 617, to develop focused strategies in areas most impacted by air pollution. AB 134 provides funding to replace older heavy-duty vehicles, equipment, and other diesel sources in our region with new, cleaner technologies. AB 617 is an exciting new effort that will bring opportunities to collaborate with environmental justice communities to

improve air quality. The meetings will include time for public comment and a question and answer portion for participants. All meetings will have Spanish interpretation available. One meeting was held on Thursday, February 22, 2018, in the city of Commerce. There will be four additional meetings held over the next two months.





# Inside SCAQMD: Air Monitoring and Analysis Team

The SCAQMD's air monitoring and analysis team, consisting of 115 staff members, operates and maintains 43 permanent stations throughout the 4-county region, and analyzes the air samples collected at these stations. In addition to overseeing this air monitoring network, the air monitoring and analysis team has initiated various innovative research and air monitoring programs such as the nation's first Air Quality Sensor Performance Evaluation Center (AQSPEC) and the fifth Multiple Air Toxics Exposure Study (MATES V). The MATES V study will use state-of-the-art monitoring technologies and low-cost sensor networks to collect near real-time data. The motivation behind this effort is to measure air toxics levels throughout the South Coast Air Basin, to characterize emissions from petroleum refineries and their impact on nearby communities, and to provide near-real time information on air toxics "hot-spots". This will be accomplished through the use of advanced air monitoring technologies such as: flight measurements, which survey refinery and other industrial areas to create




detailed air toxics maps; "optical tent" deployment, which provides continuous refinery monitoring and real-time leak detection; and ground-based efforts to detect plumes and emissions, and potential leaks from refineries and other industrial facilities. These efforts will allow the SCAQMD to expand its Community Air Toxics Investigation (CATI) efforts that are currently ongoing in Paramount and Compton. The potential impacts of the team projects such as the MATES V and CATI, include improving estimates of community level exposures to air toxics and criteria pollutants, which will then be reflected in future policy and rule development for impacted communities and to prevent future exposure from such unhealthy emissions.

## Air Quality IQ

**PM2.5 = Particulate Matter ≤ 2.5 microns**

Particulate matter refers to microscopic particles and liquid droplets in the air that can be hazardous to human health. Particulate matter size is an important factor because it determines how particulate matter travels in the air. PM2.5 refers to particles in the air that are two and one half microns or less in diameter. There are approximately 25,000 microns in an inch. Once inhaled, particulate matter can travel into the respiratory system, affecting the heart and lungs.

#### Proposed Rule 120 – Credible Evidence Rule

Proposed Rule 120 will establish that any credible evidence may be used for the purpose of establishing that a person has violated or is in violation of any approved plan or SCAQMD rule. This rule will provide standards for compliance determinations.

#### Rule 219 –

#### Equipment Not Requiring a Written Permit Pursuant to Regulation II Proposed Amended Rule 1178 – Further Reductions of VOC Emissions from Storage Tanks at Petroleum Facilities

Proposed Amended Rule 1178 will incorporate provisions to allow use of a flexible enclosure option allowed under the U.S. EPA Storage Tank Emission Reduction Partnership Program for floating roof storage tanks equipped with a slotted guide pole.

#### Rule 1469 –

#### Hexavalent Chromium Emissions from Chromium, Electroplating and Chromic Acid Anodizing Operations

Proposed Amended Rule 1469 will further reduce hexavalent chromium emissions by establishing new requirements for certain hexavalent chromium tanks that are currently not regulated and further address potential fugitive emissions from hexavalent chromium electroplating and chromic acid anodizing operations.

#### Proposed Amended Rule 408 – Circumvention

Proposed Amended Rule 408 will clarify that only nuisance odors that do not cause or have a natural tendency to cause injury, or impact the health or safety of any person, are exempt from the rule.

## File an Air Quality Complaint

**M**any businesses operating in the South Coast Air Basin must comply with SCAQMD rules to reduce air pollution. These rules are designed to protect public health. Despite a business owners best efforts, equipment breakdowns and process upsets may occur, and can result in excess emissions.

You can help protect public health by reporting air pollution nuisances. SCAQMD maintains a toll-free complaint line at 1-800-CUT-SMOG (1-800-288-7664). Complaints can be filed online at [www.aqmd.gov](http://www.aqmd.gov) or by using SCAQMD's free app for Androids or iPhones. Download the app and choose "Air Quality Issue" from the menu to send a picture and provide complaint information from your phone.

When reporting an air pollution problem, it is helpful to have the following information ready:

- Time and date the problem occurred.
- Type of problem – is it an odor, smoke, dust, etc.
- Name and address of alleged source.
- Your name, address and phone number. Names and addresses are kept confidential.

The more information you can provide, the better. Think of ways to describe the nuisance and try to identify its source. For example, if you smell a strong odor, you might be able to associate it with rotten eggs, burned plastic, ammonia or other familiar material. Descriptive information about the nuisance can be helpful to SCAQMD inspectors.

Air pollution complaints may be filed 24 hours a day, 7 days a week.
