Clean Air Awards—Leading the Future for Clean Air

May was National Clean Air Month. The South Coast Air Quality Management District (South Coast AQMD) is celebrating by announcing the opening of nominations for our 2019 Clean Air Awards. This will be the 31st Annual Clean Air Awards to recognize those who have made outstanding contributions and led the way to clean air and a healthier future.

Past Clean Air Awardees have represented the most forward-thinking leaders in government, business, medicine, technology and education. Each year, South Coast AQMD also recognizes an individual or organization for Youth Leadership in Air Quality. This award is especially inspiring as we see the future of clean air through the eyes of the next generation of leaders.

Last year, GRID Alternatives Inland Empire Solar Futures program received the youth award for their students' commitment to giving back to their communities through active participation in work-based learning. These young leaders successfully completed a rigorous training program which built upon their existing science, technology and math knowledge as well as job-readiness skills, such as public speaking and teamwork. After completing the training program, the students took their skills to their community and participated in the installation of solar panels to reduce air pollution and provide clean energy to populations

that often have the least access to these types of technologies.

In the technology and business leadership categories, it was befitting for Tesla and Proterra to receive awards related to their work in zero-emission passenger and heavy-duty vehicles, respectively. These companies are literally driving the future of clean transportation technologies through their innovation of battery electric vehicles. These clean air vehicles are critical to reducing nitrogen oxide (NOx) and diesel that contribute to more harmful air pollution in our region.

Awards were also presented to the Los Angeles World Airports in Business Leadership, California State University, Los Angeles in Clean Air Education and Outreach, Metrolink and the City of Paramount both in Model Community Achievement, and Dr. Keith Black, M.D. for the Robert M. New Additions to the South Coast AQMD Governing Board

In 2019, three new members were added to the Governing Board: Former State Senator Vanessa Delgado; Supervisor Lisa Bartlett; and Supervisor Janice Hahn.

Former State Senator, Montebello Mayor and City Councilmember, Vanessa Delgado was sworn in on May 3, 2019 as the newest member of the South Coast Air Quality Management District Governing Board as the Senate Rules Committee representative.

Delgado was elected to the City Council of the City of Montebello in November 2015 where she went on to serve as Mayor, and had roles as a member of the city's Oversight Board and served on the regional Gateway Cities Council. In August 2018, as the winner of a special election race for the 32nd district, she was sworn in as State

Senator, until the term ended in December 2018. In addition to her public service roles, Delgado is a founder and Managing Partner at a Los Angeles-based real estate development firm.

Orange County 5th District Supervisor, and current Chair, Lisa Bartlett, joined the South Coast AQMD Governing Board on March 1, 2019, as the representative for the County of Orange.

Supervisor Bartlett was elected to the Dana Point City Council and served as Mayor in 2009 and 2014, and was elected to the Orange County Board of Supervisors in 2014. She also serves on the Orange County Transportation Authority's Board of Directors, Orange County Fire Authority Board of Directors, Transportation Corridor Agencies, the Orange County Local Agency Formation

Commission, and is the first Vice President of the California State Association of Counties.

Los Angeles County Board of Supervisors Chair Janice Hahn was sworn in to the Governing Board on December 7, 2018. She has represented the Fourth District on the Board of Supervisors since November 2016. Previously, she served on the Los Angeles City Council for 10 years and in the House of Representatives for five and a half years.

While in Washington, Hahn served on the House Homeland Security Committee, Committee on Small Business and the Committee on Transportation and Infrastructure. She has been a leader on efforts to rebuild our national freight infrastructure system and level the playing field for small business owners.

South Coast AQMD to Administer \$150 Million in VW Settlement Funds for Clean Heavy-Duty Vehicles and Marine Projects

The Volkswagen (VW) Environmental Mitigation Trust provides about \$423 million to California to mitigate excess NOx emissions caused by VW's use of illegal defeat devices in certain VW diesel vehicles.

Under the settlement trust, the South Coast AQMD will administer \$150 million of the funding for two project categories:

1. Zero-Emission Class 8 Freight and Port Drayage Trucks, and
2. Combustion Freight and Marine Projects.

Other air districts will use the remaining funds towards zero-emission transit; school and shuttle buses; zero-emission freight and marine projects; and light-duty zero-emission vehicle infrastructure.

Under SB 92, state law directs the California Air Resources Board to ensure that 35 percent of California's allocation of the VW settlement benefit low-income or disadvantaged communities that are disproportionately impacted by air pollution. Current plans exceed that target, with at least 50 percent of funding expected to benefit low-income or disadvantaged communities.

Six public stakeholder workgroup meetings were held at locations throughout California from April 11 - May 6 to receive input and public comment on the implementation of the funds.

Projects anticipated for funding are estimated to result in

over 10,000 tons of NOx reductions over a 10-year period, fully mitigating the excess NOx emissions caused by the VW vehicles. In addition, advanced technology vehicle and equipment deployments will help meet local air quality and zero-emission vehicle goals.

Award-Winning App Released for Android Users

South Coast AQMD launched the Android™ version of its award-winning smartphone application previously available for iPhone users.

The iOS version of the app recently received two awards from the Government Technology and AT&T Special Districts Awards Program. The app itself was recognized for technology innovation in the "Citizens Category" while South Coast AQMD's Chief Information Officer, Ron Moskowitz was recognized in the "Leadership Category". This year, only nine awards were granted in the Special Districts/West. Of those, two were awarded to South Coast AQMD for the mobile app.

The app features interactive maps, current hourly and next-day air quality forecasts, plus real-time temperature and weather conditions for multiple cities, such as work, home, and frequently visited places, all at the same time.

Additional features include alternative fueling locations and driving directions, event announcements and customizable notifications for changes in air quality levels, or health alerts due to events such as wildfires. The newly released Android version is now available in the Google Play app store.

Incentives to Buy Zero-Emission Commercial Electric Lawn and Garden Equipment

South Coast AQMD is offering \$2.5 million in incentive funds to help commercial gardeners and landscapers, local governments, school districts, colleges and non-profit organizations buy new zero-emission, battery-electric lawn and garden equipment to replace their old, polluting gasoline- or diesel-powered ones. Participants may receive up to 60 percent off the purchase price of new equipment. This program is not available to individual residents who are not gardeners or landscapers.

Gas- and diesel-powered chainsaws, lawn mowers, leaf blowers and hedge trimmers produce hazardous emissions that expose operators and residents to increased cancer risks, air toxics, carbon monoxide and microscopic particles that can become lodged deep in the lungs.

Participants will receive significant discounts applied at point of purchase on approved equipment. For example, a leaf blower with a backpack battery and a charger that retails for \$1,400 can be purchased for only \$560 plus tax, a 60 percent discount.

Participants will be able to purchase qualifying equipment from ECHO, Husqvarna, Makita, Mean Green, Oregon and STIHL from authorized dealers in Riverside, Orange, Los Angeles and San Bernardino counties at a reduced price in exchange for an equivalent, operable piece of diesel- or gasoline-powered equipment. Manufacturers will accept and scrap the old equipment with priority given to participants that are located in environmental justice communities in the South Coast Air Basin.

According to studies by the California Air Resources Board (CARB)

- 42 percent of engines fail CARB's evaporative emission test.
- Operators are exposed to benzene and butadiene, increasing their cancer risks.

Cities in Action—South Pasadena

In 2015, South Pasadena became the first city in the nation certified as an AGZA Green Zone® City by the American Green Zone Alliance after converting all equipment used for routine grounds maintenance of parks, medians and other city-owned property from gas- and diesel-power to zero-emission.

The first phase of conversion marked the beginning of using cleaner and quieter equipment in the city's largest parks including Arroyo Seco and Garfield, the city library grounds, the War Memorial, City Hall and two water tanks. The citywide green operations span 79 acres, with 48 acres of mowing, 30 acres of blowing hardscapes, 1.7 acres of hedge trimming, 16,000 sq. ft. of hand raking, and over 13 miles of edging.

In 2017, South Pasadena became the first city in the country to achieve AGZA Green Zone Golf Course certification for its municipal 18-hole, par-3 Arroyo Seco Golf Course through the use of gas-free equipment. Electric equipment replaced all gas-powered lawn mowers, blowers, trimmers, and hedge clippers. A diesel tractor, for which there was no viable electric alternative, was upgraded to a Tier 4 compliant diesel model, slashing smog-forming emissions by about 90 percent.

Every year South Pasadena's new electric equipment is preventing the creation of 59 tons of airborne pollutants that cause respiratory problems such as asthma and lung disease, including emphysema and cancer, in the local community. The transition from gasoline to more cutting-edge electric technology instantly eliminated all of the hazardous emissions created by internal combustion engines including: carbon dioxide, carbon monoxide, nitrogen oxides, volatile organic compounds, and particulate matter.

In 2017 the Professional Grounds Maintenance Society and the Coalition for Clean Air both granted the City of South Pasadena their highest sustainability awards for these efforts.

AB 617 Self Nominations Now Open

AB 617 Community Air Initiatives addresses the disproportionate impacts of air pollution in environmental justice communities and requires local air districts to take specific actions to reduce air pollution and toxic air contaminants from commercial and industrial sources. Most importantly, the cornerstone of AB 617 is the understanding that community members must be active partners in envisioning, developing, and implementing actions to clean up the air in their communities.

Year two community nominations are currently underway. The deadline for submitting a self-recommendation is June 30, 2019. Communities are encouraged to submit self-recommendations by:

AB 617 Update

South Coast AQMD is actively conducting exciting and comprehensive community-based efforts that focus on improving air quality and public health in environmental justice communities through Assembly Bill (AB) 617. As part of this multi-year effort, three Community Steering Committees were established in the communities of:

- Wilmington, West Long Beach and Carson;
- Boyle Heights, East Los Angeles, and West Commerce; and,
- San Bernardino and Muscoy.

Meetings are continuing monthly in each of the communities, so that committee members and the public can provide input on community plans and help guide the program to improve air quality in the community.

The steering committees have been providing input for the **Community Air Monitoring Plans and Community Emission Reduction Plans**, with drafts set to be released in June. South Coast AQMD will begin air monitoring in these communities in July of 2019. The Community Emission Reduction Plans will outline actions to address the communities top air quality priorities.

In addition to providing input, committee members have been working collaboratively, sharing information, and giving updates on local efforts and programs related to improving air quality.

Verdelyia Jacquelyn Lundy, or more familiarly known as Jackie Dix to her South Coast AQMD family, passed away March 2, 2019.

Born in 1944, in Los Angeles, California, Jackie became the first African American student to attend the predominately Jewish/Armenian Burnside Avenue Elementary School. During her formative years Jackie studied violin, ballet, modern dance, and tennis.

Her passions in life included music; such as attending Barbra Streisand concerts with her daughter Tonya Michele Poston. She was a devoted Raiders football fan regardless of the team's track record. She enjoyed traveling, such as visiting the Terra Cotta Army Sculptures in Xi'an, China. She was an avid Olympics fan and attended all but one Summer Olympic Games since 2000.

Jackie came to the South Coast AQMD in 1980 by way of working at Los Angeles County. She dedicated 38 years of her life to public service, and retired in 2003. Jackie served as Clerk of the Board for 23 years.

During her years at the South Coast AQMD she became lifelong friends with a group of women known as the Pizza Group. During the course of 40 years of friendship these ladies traveled, cruised, and celebrated major life events together. In the words of the Pizza Group, "Jackie was strong, but soft spoken, serious but fun, jokester at times, smart but humble, a good listener but first to tell you just what you needed to hear. And her smile - always present and always memorable. Jackie didn't just care for each of us, but she cared for those important to us as well. It's Smog Season, Take Note When Planning Your Outdoor Activities This Summer

May 1 officially marked the start of the smog season when hot, stagnant days can increase the formation of ground-level ozone—commonly known as smog—that can lead to unhealthy air quality.

During smog season, South Coast AQMD reminds residents to stay informed of air quality levels in their area and adjust their outdoor activities accordingly. There are a number of ways to access air quality information

Young children, older adults, and those with respiratory problems are particularly at risk to health effects from smog pollution. South Coast AQMD advises avoiding rigorous outdoor activities, such as running, soccer, or football when air quality conditions reach unhealthy levels.

Smog season officially ends on October 31, although other air pollutants can be high during the rest of the year.

Rule 1106: Marine Coating Operations Ru1106.1: Pleasure Craft Coating Operations

This action is for the limited purpose of consideration of staff's request that Proposed Amended Rule 1106 and Proposed Rescinded Rule 1106.1 be submitted to the U.S. EPA for inclusion into and removal from the SIP, respectively, which inadvertently was not noticed for consideration at the May 2019 Board meeting.

July

Rule 301: Permitting and Associated Fees

Proposed Amended Rule 301 will add a requirement that facilities submitting annual emissions reports that must include a certification that the information contained in the report is accurate to the best knowledge of the individual submitting the report.

Regulation IX: Standards of Performance for New Stationary Sources (NSPS)

Regulation X: National Emission Standards for Hazardous Air Pollutants (NESHAPS)

Proposed amendments to Regulations IX and X are periodically made to incorporate by reference new or amended federal standards that have been enacted by U.S. EPA for stationary sources. Regulations IX and X provide stationary sources with a single point of reference for determining which federal and local requirements apply to their specific operations.

Proposed Amended Rule 1147 will remove equipment that will be regulated under Proposed Rule 1147.1 and evaluate the existing NOx emission limits.

Rule 1407: Control of Emissions of Arsenic, Cadmium and Nickel from Non-Ferrous Metal Operations

Proposed Rule 1109.1 is an industry-specific rule, will establish an ammonia emission limit for pollution controls with ammonia emissions, and update monitoring, reporting, and recordkeeping requirements. Rule 1109 is proposed to be rescinded.
