Working Group Meeting Proposed Amended Rule (PAR) 1106 – Marine and Pleasure Craft Coating Operations

Purpose of this Working Group Meeting

The South Coast Air Quality Management District (SCAQMD) has scheduled a working group meeting to solicit comments and suggestions from the public on Proposed Amended Rule (PAR) 1106 - Marine Coating Operations.

PAR1106 will be considered for amendment by the SCAQMD Governing Board at a public hearing **now scheduled for May 3, 2019**. The working group meeting is intended to review the proposal under consideration with potentially impacted stakeholders and other interested parties, and allow for comments and discussion prior to a subsequently scheduled public workshop.

Proposed Amendments Under Consideration

Staff is proposing to subsume the requirements of Rule 1106.1 - Pleasure Craft Coating Operations into Rule 1106, and include the following requirements:

- Coating application transfer efficiency
- Most restrictive VOC content limit provision
- Labeling consistent with other coating rules

- Revised VOC content limits for antenna coatings, pretreatment wash primers, repair and maintenance thermoplastic coatings, inorganic zinc coatings, and specialty marking coatings to align with the U.S. EPA Control Techniques Guidelines and local APCDs/AQMDs
- New categories for antifouling coatings used on aluminum substrates for marine coating operations, marine deck primer sealant, mist coating, nonskid coating and organic zinc coating
- Clarification of the touch-up coating definition and exemption
- Prohibition of possession, specification and sale provisions.

Staff is also proposing to include administrative changes to the rule by removing obsolete rule language, making minor revisions and editorial corrections, and making necessary updates to the definitions for consistency with other SCAQMD rules.
