I oppose the amendments to Rule 1111 and 1121, as 3 of our most critical appliances run on gas. If the rules are amended the economic effects will be devastating for many during this time of inflation. A recent analysis by the Cost of Living Council, an alliance of local homeowners, renters, small businesses, and workers, projects that this mandate will cost families in our region \$7.7 billion over the next 25 years. Replacing gas systems with electric ones could run \$47,800 for a single-family home, or \$40,100 for a multi-family rental unit. Even just keeping our current gas appliances could cost an extra \$1,510 per replacement in new fees. And it won't stop at homeowners. Landlords facing massive upgrade costs will pass them on to renters. Small businesses will see higher operating expenses.

Jobs will be lost. And yet, these proposals are being rushed forward without a clear plan to support working families through the transition. Public Power Safety Shutoffs (PSPS) pose a serious risk to households that rely entirely on electricity. When power is cut, sometimes for hours or even days during fire seasons, homes with all-electric appliances lose access to heating, hot water, cooking, and in some cases, essential medical equipment. For families with young children, seniors, or those with health conditions, this is not just an inconvenience, it's dangerous. Additionally, making our appliances solely reliant on electricity could make us more vulnerable to cyber attacks of the power grid. Forcing unaffordable changes on millions of Californians without financial assistance, economic safeguards, or public consensus is not responsible governance.
