Dear Chair Delgado and Governing Board Members:

I am writing to express opposition to the proposed amendments to Rules 1111 and 1121 for the following reasons:

1. Modern natural gas appliances are energy efficient and natural gas is an affordable source for heating, cooking and hot water. Forcing everyone to use the electric equivalent would not do much to improve air quality and will only increase the already outrageous electric bills that we are already paying.
2. California's electric grid is antiquated and in need of modernization. It wasn't designed to handle the increased loads we currently have today. Because of its age, the current grid is fragile. Blackouts are occurring during periods of peak demand. Before this takes effect and before placing more demand on an already unreliable electric grid, the grid must be upgraded to handle the predictable increased load.
3. These amendments could place a serious financial burden on homeowners and businesses - not only the cost of the appliances but also any required retrofit potentially running into thousands of dollars. The economic climate is such that families are rightfully focused on taking care of their families and should not have to face the burden of a potentially costly retrofit just to warm their home or feed their families.
