Dear Distinguished Board Members of the South Coast AQMD,

During this past winter's devastating wildfires, how many of you experienced losing power in your homes for 9 out of 14 days? I live more than 40 miles from the nearest fire, yet Southern California Edison shut off electricity to my home for nearly a third of the month as part of their Public Safety Power Shutoff (PSPS) policy.

During that time, my family relied on our natural gas furnace, natural gas stove, and a gasoline-powered generator to stay warm, prepare food, and maintain basic living conditions. Without these gas-powered systems, we would have faced extremely difficult and unsafe conditions in our own home.

It is deeply concerning that while utility companies are not being held accountable for modernizing and hardening the electrical grid—such as by investing in underground lines or more resilient infrastructure—state and regional agencies are considering policies that would eliminate or severely restrict access to gas-powered appliances. These policies assume a level of grid reliability that simply does not exist today.

If the state cannot guarantee dependable electricity during critical emergencies, how can it ask its residents to live in homes that lack alternative means to heat, cook, or power their lives when the grid fails?

I urge you to consider the lived experiences of your constituents—particularly during emergencies—before mandating policies that reduce their ability to remain safe and self-sufficient. Energy reliability must be addressed before imposing restrictions that further limit the options families have during times of crisis.

Thank you for your service and attention to this urgent matter.
