2006-07 Work Program

On October 6, 2006, the AQMD Governing Board approved awards to two vendors to implement the public school district portion of the CNG School Bus Incentives portion of the MSRC's FY 2006-07 Work Program. These contracts are executed. Also on October 6, 2006, the Board approved an award for implementation of the Advanced Natural Gas Heavy-Duty Engine Incentives portion of the FY 2006-07 Work Program. This contract is executed.

On December 1, 2006, the AQMD Governing Board approved two sole-source awards to assist in administering the Mountain Area CNG School Bus Demonstration portion of the FY 2006-07 Work Program, as well as a sole-source award to the Coachella Valley Association of Governments to administer a PM10 Reduction Street Sweeping Operations Program. Contracts for these projects are with the prospective contractor for signature or executed.

On March 2, 2007, the AQMD Governing Board approved awards to four applicants for the Advanced Low-Emission Urban Transit Bus Engine Program. Contracts for these projects are under development or with the prospective contractor for signature.

On May 4, 2007, the AQMD Governing Board approved an award under the Alternative Fuel Infrastructure Funding Opportunities Program. The contract for this project is with the prospective contractor for signature.

On July 13, 2007, the AQMD Governing Board approved awards to two applicants under the Alternative Fuel Infrastructure Funding Opportunities Program. The contract for one of these projects is executed. The other project became ineligible due to a need to change the station location, and the funds reverted to the AB 2766 Discretionary Fund.

On September 7, 2007, the AQMD Governing Board approved 8 awards under the Alternative Fuel Infrastructure Funding Opportunities Program, 26 awards under the Local Government Match Program, and 9 awards under the Advanced Low-Emission Heavy-Duty Natural Gas Solid Waste Collection Engine Program. The contracts for these projects are under development, undergoing internal review or with the prospective contractors for signature.

On October 5, 2007, the AQMD Governing Board approved 18 awards under the "Showcase" Off-Road Diesel Construction Equipment Retrofit Program. The contracts for these projects are under development, undergoing internal review, with the prospective contractors for signature or executed.

On November 2, 2007, the AQMD Governing Board approved two awards under the Advanced Low-Emission Heavy-Duty Natural Gas Solid Waste Collection Engine Program. The contracts for these projects are under development.

Work Program Status

Contract Status Reports for work program years with open and pending contracts are attached. MSRC or MSRC-TAC members may request spreadsheets covering any other work program year.

All contracts and invoicing under these programs are now complete.

FY 2000-01 Work Program Contracts

One Regular contract remains open under this work program. All Alternative Fuels Subvention Match Program contracts are now closed.

Nine regular and eight Local Match contracts from this work program year are open. One contract closed during this period: R.F. Dickson Co., Contract #MS04050 – Upgrade CNG Station.

FY 2004-05 Work Program Contracts

Six regular, ten Local Match, and twelve Diesel Exhaust After-treatment contracts from this work program year are open. Three contracts closed during this period: Sunline Transit Agency, Contract #MS05038 – Purchase Fifteen CNG Buses; City of Santa Monica, Contract #MS05048 – Upgrade CNG Station; and Los Angeles County Department of Beaches and Harbors, Contract #ML05007 – Purchase Five Medium-Duty CNG Vehicles.

Contract Execution Status

Of the Phase II Local Match applications which received AQMD Board approval on December 1, 2006, one pending contract has not proceeded to internal review: the County of Los Angeles, Department of Public Works was awarded \$175,000 to purchase seven LPG heavy-duty trucks. Department staff have indicated that they expect to be declining the award, and an official letter is expected soon. Another pending contract was initially sent to the prospective contractor, the City of Colton, in March 2007. The City was awarded \$50,000 towards the purchase of two heavy-duty CNG pickups. City staff have indicated that the original contracts were lost, and replacements have been sent.
