

## APRIL 2002 AIR QUALITY


Air quality statistics in the South Coast Air Basin and the desert area of Coachella Valley in the Salton Sea Air Basin for April 2002 are shown and summarized in the

following figures and Tables. Figure 1 compares the maximum pollutant concentrations recorded in April 2002 to the maximum concentrations recorded for April 2001. The maxima are shown as percentages of the state ambient air quality standards. Figure 2 shows the maxima as percentages of the federal standards. Table 1 shows the state and federal ambient air quality standards for criteria pollutants, the maximum concentrations recorded in April 2002 and the location where the maximum concentration was recorded. Figure 3 shows the location of the District's air monitoring stations in each source/receptor area. The number of days exceeding the state and federal standards and the maximum concentrations of the pollutants in each source/receptor area during April 2002 are summarized in Table 2.



\*\*Higher lead concentrations were recorded at special monitoring sites located immediately downwind of stationary sources of lead.

Maximum Concentrations as Percentages of State Standards




**Figure 2**
