This bimonthly publication satisfies the requirements for reporting on air quality in the South Coast Air Basin set by California legislation (Chapter 1301, Statutes of 1987; Health and Safety Code Section 40451(d)), and supplies similar information for the areas of the Salton Sea Air Basin (Coachella Valley) served by the District.

Based on the "Review of the California Ambient Air Quality Standards for Ozone," the staff of California Air Resources Board is considering revising the California Ozone Standard to establish a new 8-hour average standard of 0.070 ppm in order to adequately protect public health, including infant and children.

May and June 2004 Air Quality

Air quality statistics in the South Coast Air Basin and the desert area of Coachella Valley in the Salton Sea Air Basin for the months of May and June are shown and summarized in the following figures and tables.


Figure 1 shows the maximum pollutant concentrations recorded during May - June 2004 as percentages of the state and federal ambient air quality standards.

Table 1 (on page 2) shows the state and federal ambient air quality standards for criteria pollutants, the maximum concentrations recorded during May/June 2004 and the location where the maximum concentration was recorded.

During May and June, 2004, the concentrations of carbon monoxide, nitrogen dioxide, sulfur dioxide, PM2.5, sulfate, and lead were within state and federal air quality standards at all locations

monitored by the District. Ozone concentrations exceeded the state federal standards at most locations. PM10 concentrations met the federal standard at all locations monitored in the District, while exceeding the state standard at some locations.

Figure 2 shows the location of the District's air monitoring stations in each source/receptor area. The source/receptor area names and numbers, air monitoring station numbers, the number of days exceeding the state and federal standards and the maximum concentrations of the pollutants in each source/receptor area for the months of May and June 2004 are summarized in Tables 2 and 3, respectively.

Maximum Concentrations as Percent of State and Federal Standards for May and June 2004


